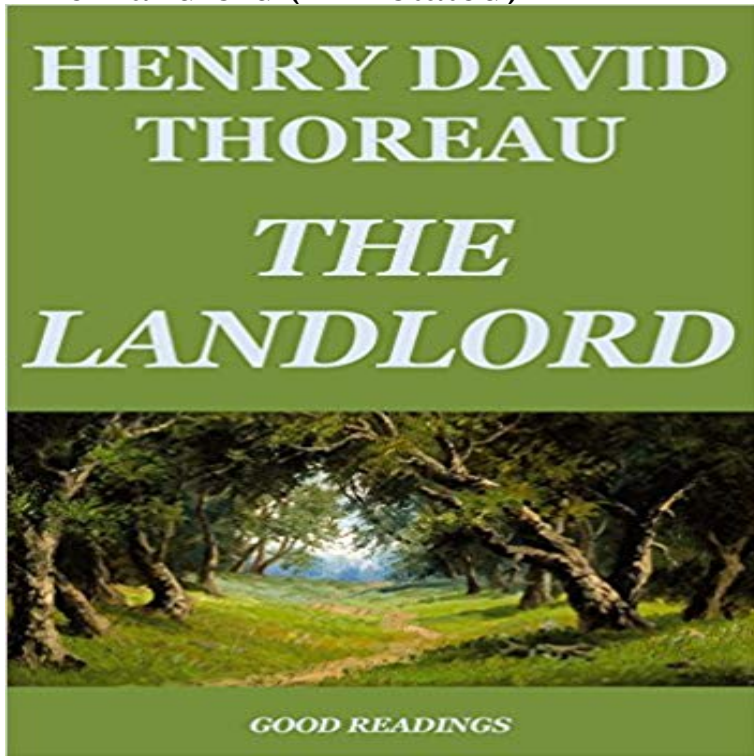


## The Landlord (Annotated)
